Working with other members of the Alliance, she established a very successful and meaningful dialogue among Ligon's teachers on issues of race in the school. As a woman business owner, Adrienne has been recognized by Business Leader Magazine with a Women Extraordinaire Award and with a Women in Business Award from Triangle Business Journal. She was a finalist in the first Enterprising Women of the Year Awards given by Enterprising Women Magazine.
